## WEDDING PHOTOGRAPHY CONTRACT

I. **PARTIES.** This Wedding Photography Contract (“Contract”) made on ..... is between:

II. **TERMS.** The Photographer and Client agree as follows:

- b. Fees. The Client agrees to pay the Photographer a total amount of \$..... of the Package ..... for their services. This amount includes access to all edited photos taken at the wedding and all terms stated in the .....Package (Wedding Packages attached).
- c. Payment. The Client agrees to pay the Photographer with Deposit of \$..... to lock in the date and upon signing this Contract, and the Balance of \$ ..... 2 weeks before the Wedding date.
- d. Deposit. The Client agrees that the Deposit is Non-refundable but Transferrable to use for other Photo Sessions.
- e. Services. The Photographer agrees to take and deliver professional photos of the Couple and the guests including family members and Bridal Party, in accordance with industry standards and as reasonably requested by the Client during the course of the wedding.
- f. Substitution. The Photographer may substitute another equally skilled photographer in the case of illness or incidents. The Client will be given notice as soon as possible in such a circumstance.
- g. Watermarks. All images shown with watermarks in the Sneak Peek delivery, or any limitations, shall be removed upon full payment to the Photographer.
- h. Copyrights. The Photographer holds the Copyrights until all images are transferred to the Client.
- i. Use of Photos. The Photographer reserves the right to use up to 20 images as Sneak Peek photos to be posted on The Photographer’s Social Media and Website.
- j. Photographer’s Cancellation. If the Photographer is forced to cancel the services that is beyond their control, all funds paid by the Client shall be returned and the Photographer shall be held harmless from any legal or financial liability.

This Contract incorporates the entire understanding of the Photographer and Client. Any modification of this Contract must be in writing and signed by both parties.
